Dr. Lionel Higgins has informed us of the death of Mr. Peter Haig-Thomas, noted English collector. He left his extensive collection to the British Museum (Natural History). He was noted for the accuracy of his data.

From Dr. Higgins also comes news of the discovery of a new species of Erebia from the Eastern Carpathians of the Alps. This new species has been named E. carpathicola by Popescu-Gorj and Alexinischi.

The XIth International Congress of Entomology will take place in Vienna from the 17th to 25th of August 1960 under the Chairmanship of Professor Karl E. Schedl, PhD. The languages of the Congress are German, English, French and Italian. The object of the Lepidopterists' Society, which was formed in May, 1947,
and formally constituted in December, 1950, is "to promote the science of lepidop-
terology in all its branches....to issue a periodical and other publications on
Lepidoptera; to facilitate the exchange of specimens and ideas by both the profes-
sional worker and the amateur in the field; to secure cooperation in all measures"
directed toward these aims (Constitution, Art. II). A special goal is to encourage
free interchange among the lepidopterists of all countries.

Membership in the Society is open to all persons interested in any aspect of
lepidopterology. Prospective members should send to the Treasurer the full dues
for the current year together with their full name, address, and special lepidop-
terological interests. Remittances in dollars should be made payable to The
Lepidopterists' Society.

Sustaining Members --- annual dues \$10.00 (U. S. A.)
Life Members --- single sum \$75.00 (U. S. A.)
